**Resolution No. 96 – 2018**

**URGENT RESOLUTION AUTHORIZING HON. MARK P. PALABRICA, MUNICIPAL MAYOR, MUNICIPALITY OF BINGAWAN, ILOILO TO ENTER AND SIGN FOR AND IN BEHALF OF THE MUNICIPALITY OF BINGAWAN, ILOILO A MEMORANDUM OF AGREEMENT WITH BINGAWAN BAPTIST CHURCH, INC. REPRESENTED BY ITS SENIOR PASTOR, REV. LOWELL LEYSA FOR THE SPIRITUAL THERAPY, PSYCHOLOGICAL NEEDS AND SOCIAL SUPPORT IN THE COMMUNITY AFTER ANY CALAMITIES/DISASTERS.**

**WHEREAS**, the Local Government Unit is mandated by law to extend assistance to victims of disasters;

**WHEREAS**, the LGU has a Five percent (5%) Municipal Disasters Risk reduction Management Fund, of the amount appropriated for MDRRMF, thirty percent (30%) shall be allocated as Quick Response Fund (QRF) for the relief and recovery programs in order that situation and living conditions of people in communities or areas stricken by disasters, calamities, epidemics, complex emergencies, may be normalized as quickly as possible;

**WHEREAS**, the BBC is a SEC registered no-profit religious organization with SEC Registration No. 137770 situated within the territorial jurisdiction of the LGU;

**WHEREAS**, the LGU cannot utilize their thirty per cent (30%) MDRRM Fund before the occurrence of any disaster;

**WHEREAS**, by reason of limitations provided in the use of the said fund, the LGU recognizes the need to make arrangements with the local faith based organization for the spiritual therapy, psychological needs and social support in the community after any calamities;

**WHEREAS**, Section 22 (c) of RA 7160 provides that “no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the Sanggunian concerned”.

**RESOLVED AS IT IS HEREBY RESOLVED**, to authorize Hon. Mark P. Palabrica, Municipal Mayor, Municipality of Bingawan, Iloilo to enter and sign for and in behalf of the Municipality of Bingawan, Iloilo a Memorandum Of Agreement with Bingawan Baptist Church, Inc. represented by its senior Pastor, Rev. Lowell Leysa for the spiritual therapy, psychological needs and social support in the community after any calamities/disasters.
