RESOLUTION RECOMMENDING THE AWARD OF CONTRACT FOR THE PURCHASE OF COVID-19 SPECIMEN COLLECTION TUBE KITS TO BIOSITE MEDICAL INSTRUMENTS PURSUANT TO SECTION 53.2 (NEGOTIATED PROCUREMENT-EMERGENCY CASES) OF THE IMPLEMENTING RULES AND REGULATIONS (IRR) OF RA 9184

WHEREAS, Republic Act No.9184 provides for the modernization, standardization and regulation of the procurement activities of the Government;

WHEREAS, with the prior approval of the Municipal Mayor, as the head of the procuring entity, the Municipal Government of Bingawan may, whenever justified by the conditions provided for RA 9184, resort to any alternative methods of procurement provided for in the Implementing Rules and Regulations of RA 9184 (IRR);

WHEREAS, through Proclamation 929, dated March 16, 2020, the President of the Philippines declared the entire country under the State of Calamity due to Corona Virus Disease 2019;

WHEREAS, the Municipal Mayor has approved the "NEGOTIATED PROCUREMENT-EMERGENCY CASES" mode of procurement for the "PURCHASE OF COVID-19 SPECIMEN COLLECTION TUBE KITS" as indicated in the Annual Procurement Plan recommended by the Bids and Awards Committee;;

WHEREAS, the Bids and Awards Committee negotiated and received filled-up Request for Quotation Form from **BIOSITE MEDICAL INSTRUMENTS** which offered the lowest and most advantageous price to the Municipal Government of Bingawan;

NOWHEREFORE, RESOLVED AS IT IS HEREBY RESOLVED by member of the Bids and Awards Committee to recommend the award of contract for the **PURCHASE OF COVID-19 SPECIMEN COLLECTION TUBE KITS** to **BIOSITE MEDICAL INSTRUMENTS** in the amount of **SEVENTY SIX THOUSAND PESOS (Php76,000.00)**.
